

Data protection

Korean Air collects and uses personal data for the purpose and within the scope of providing air transportation service. You can choose to opt out of the collection and use of your personal data, but please note that you will be unable to use the services provided by Korean Air.

Your rights under the data protection regulation:

- You can opt out of the collection and use of your personal data,
- You can view, edit, and delete your personal data, and you can opt out of or withdraw your consent to the use and collection of your personal data,
- You can request your personal data to be transferred to another administrator,
- You can submit a complaint to the supervising authorities (especially for violation of personal data regulation if you are a resident or work in a company of an EU state),
- In accordance with the French personal data regulation, you can set instructions for the processing of your data after your death
